ORDER

As the Central Government has accepted recommendations of the 7th Central Pay Commission, inter-alia, as revision of the Pay Scales of All India Services.

In this context the Ministry of Personnel, Public Grievances and Pension, Department of Personnel and Training, Government of India has issued notifications as detailed below in respect of All India Service officers:-

2.	G.S.R. 910 (E) dated 23.09.2016	Notifying the Indian Police Service (Pay) Rules, 2016
3.	G.S.R. 924 (E) dated 28.09.2016	Notifying the Indian Forest Service (Pay) Rules, 2016

The State Government has decided to apply with effect from 01.01.2016 the Pay Scales and all provisions as contained in the above 3 notifications of Government of India in respect of All India Service Officers borne on the Cadre of State of Rajasthan. In addition to above any amendment issued by the Government of India in this regard from time to time may also be applied.

Therefore the sanction of the Governor is hereby accorded for implementations of the pay scales with effect from 01.01.2016 and all provisions as contained in the said 3 notifications of the Government of India to the officers of All India Services (viz IAS, IPS and IFS) borne on the cadre of State of Rajasthan on the following terms and conditions:-

- (1) **Exercise of options:** The officers shall submit their options to Department of Personnel within three months of the date of issue of this order.
- (2) **Payment of amount of Arrears:** The amount of arrears of Pay and Allowances to the All India Services Officers shall be paid w.e.f. 01.01.2016.
