NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Subordinate Offices Ministerial Service Rules, 1999, namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan Subordinate Offices Ministerial Service (...Amendment) Rules, 2017.

(2) They shall be deemed to have come into force with effect from 01-4-2017

2. Amendment of rule 2.- In sub-clause (ii) of clause (a) of rule 2 of the Rajasthan Subordinate Offices Ministerial Service Rules, 1999 hereinafter referred to as the said rules, for the existing expression "Office Superintendent cum Assistant Administrative Officer", the expression "Additional Administrative Officer" shall be substituted.

3. Amendment of rule 6.- In first proviso to clause (a) of sub-rule (1) of rule 6 of the said rules, for the existing expression "Clerk Grade-II", the expression "Junior Assistant" shall be substituted.

4. Amendment of rule 6A.- In sub-rule (1) of rule 6A of the said rules, for the existing expression "Clerk Grade-II", the expression "Junior Assistant" shall be substituted.

5. Amendment of rule 6B.- In sub-rule (1) of rule 6B of the said rules, for the existing expression "Clerk Grade-II", the expression "Junior Assistant" shall be substituted.

6. Amendment of rule 6C.- In clause (a) of sub-rule (1) of rule 6C of the said rules, for the existing expression "Clerk Grade-II", the expression "Junior Assistant" shall be substituted.

7. Amendment of rule 21- In rule 21 of the said rules, for the existing expression "Clerk Grade-II", wherever occurring, the expression "Junior Assistant" shall be substituted.

8. Amendment of rule 23.- In rule 23 of the said rules, for the existing expression "Clerk Grade-II", the expression "Junior Assistant" shall be substituted.

9. Amendment of rule 24.- In rule 24 of the said rules, for the existing expression "Clerk Grade-II", wherever occurring, the expression "Junior Assistant" shall be substituted.

10. Amendment of rule 28.- In rule 28 of the said rules,-

- (i) in heading, for the existing expression "**Clerk Grade-II**", the expression "**Junior Assistant**" shall be substituted;
- (ii) in sub-rule (1), for the existing expression "Clerk Grade-II", the expression "Junior Assistant" shall be substituted; and
- (iii) in sub-rule (3), for the existing expression "Clerk Grade-II", the expression "Junior Assistant" shall be substituted.

11. Amendment of rule 37.- In proviso (i) to sub-rule (1) of rule 37 of the said rules, for the existing expression "Clerk Grade-II", the expression "Junior Assistant" shall be substituted.

12. Amendment of Schedule-I.- In Schedule-I appended to the said rules,-

- (i) in column 7 against serial number 1, for the existing expression "5 years' experience on the post of Administrative Officer", the expression "25 years' experience in all on the posts included in the General Wing" shall be substituted;
- (ii) in column 6 against serial number 2, for the existing expression "Office Superintendent cum Assistant Administrative Officer", the expression "Additional Administrative Officer" shall be substituted;
- (iii) in column 6 against serial number 3, for the existing expression "Office Superintendent cum Assistant Administrative Officer", the expression "Additional Administrative Officer" shall be substituted;
- (iv) in column 7 against serial number 3, for the existing expression "5 years' experience on the post of Office Superintendent cum Assistant

- Administrative Officer", the expression "3 years' experience on the post of Additional Administrative Officer" shall be substituted;
- (v) in column 6 against serial number 4, for the existing expression "Assistant Office Superintendent", the expression "Assistant Administrative Officer" shall be substituted ;
- (vi) in column 6 against serial number 5, for the existing expression "Assistant Office Superintendent", the expression "Assistant Administrative Officer" shall be substituted;
- (vii) in column 6 against serial number 6, for the existing expression "Assistant Office Superintendent", the expression "Assistant Administrative Officer" shall be substituted;
- (viii) in column 9 against serial number 6, for the existing expression "Assistant Office Superintendent", the expression "Assistant Administrative Officer" shall be substituted;
- (ix) in column 9 against serial number 6, for the existing expression "Clerk Grade-I", the expression "Senior Assistant" shall be substituted ;
- (x) in column 2 against serial number 7, for the existing expressions ""Office Superintendent cum Assistant Administrative Officer", the expression "Additional Administrative Officer" shall be substituted;
- (xi) in column 6 against serial number 7, for the existing expression "Assistant Office Superintendent", the expression "Assistant Administrative Officer" shall be substituted;
- (xii) in column 7 against serial number 7, for the existing expression "4 years' experience of the post of Assistant Office Superintendent", the expression "2 years' experience of the post of Assistant Administrative Officer", shall be substituted;
- (xiii) in column 2 against serial number 8, for the existing expression "Assistant Office Superintendent", the expression "Assistant Administrative Officer" shall be substituted;
- (xiv) in column 6 against serial number 8, for the existing expressions "Clerk Grade-I", the expression "Senior Assistant" shall be substituted;



- (xv) in column 2 against serial number 9, for the existing expressions "Clerk Grade I", the expression "Senior Assistant" shall be substituted;
- (xvi) in column 6 against serial number 9, for the existing expressions "Clerk Grade II", the expression "Junior Assistant" shall be substituted; and
- (xvii) in column 2 against serial number 10, for the existing expression "Clerk Grade II", the expression "Junior Assistant" shall be substituted.

13. Amendment of Schedule-II.- In Schedule-II appended to the said rules,

- (i) in the heading, for the existing expression "CLERK GRADE-II, the expression "JUNIOR ASSISTANT" shall be substituted; and
- (ii) in Explanation number (1), for the existing expression "Clerk Grade II", the expression "Junior Assistant" shall be substituted.
