



**5. Amendment of rule 2 .-** In rule 2 of the said rules,-

- (i) in clause (a), for the existing expression "Woman and Child", the expression "Integrated Child" shall be substituted;
- (ii) in clause (d), for the existing expression "Women & Child", the expression "Integrated Child" shall be substituted;
- (iii) in clause (e), for the existing expression "Women & Child", the expression "Integrated Child" shall be substituted; and
- (iv) in clause (i), for the existing expression "Women & Child", the expression "Integrated Child" shall be substituted.

**6. Amendment of rule 6 .-**In rule 6 of the said rules,-

- (i) in proviso to clause (a) of sub-rule 1,-
  - (a) for the existing expression "Assistant Project Officer (DWCRA)", the expression "Assistant Director (ICDS)" shall be substituted; and
  - (b) for the existing expression "Rules, 1962", the expression "Rules, 1999" shall be substituted; and
- (ii) in sub-rule (3),-
  - (a) the existing proviso (ii) shall be deleted; and
  - (b) the existing proviso (iv) shall be substituted by the following, namely:-
    - "(iv) the cadre of Dy. Director (ICDS) shall be filled in by the following manner, namely:-
      - (a) 75% by promotion from Child Development Project Officer (CDPO) and Assistant Director (ICDS); and
      - (b) 25% from Rajasthan Administrative Service Officers.

Note: In the event of non-availability of Officers of Rajasthan Administrative Service, the vacancies may be filled in by taking

Officers of equivalent grade from other departments on deputation till such time as the Officers of the Rajasthan Administrative Service are made available."

**7. Amendment of rule 23.**-The existing proviso to rule 23 of the said rules, shall be substituted by the following provisos, namely :-

"Provided that 100% posts of Supervisor shall be filled in by direct recruitment out of which 50% from open market and 50% amongst Anganwadi Workers through written examination, conducted by the Appointing Authority or Board, as the case may be, in accordance with the scheme and syllabus specified in Schedule-III.

Provided further that the decision of the Appointing Authority or Board, as the case may be, as to the eligibility or otherwise of candidate shall be final."

**8. Amendment of rule 27.**- In rule 27 of the said rules,-

(i) in item (iv) of clause (a), for the existing expression "Woman & Child", the expression "Integrated Child" shall be substituted; and

(ii) in clause (b),-

(a) in item (i), for the existing expression "Woman & Child ", the expression "Integrated Child" shall be substituted;

(b) in item (iii), for the existing expression "Woman & Child ", the expression "Integrated Child" shall be substituted; and

(c) in item (iv), for the existing expression "Woman & Child ", the expression "Integrated Child" shall be substituted.
