ORDER

Sub. :- Payment of Dearness Allowance to All India Service Officers-revised rates effective from 01.01.2017.

The Government of India, Ministry of Finance, Department of Expenditure vide Office Memorandum F.No.1/3/2008-E.II(B) dated 07th April, 2017 modified the Dearness Allowance rates w.e.f. 1st January, 2017 for the employee of Central Government Employee who continue to draw their pay in pre-revised pay band as per 6th Central Pay Commission. The Governor is pleased to decide that the Dearness Allowance payable to All India Service Officers w.e.f. 1st January, 2017 shall stand modified as follows :-

Date from which payable	Revised rate of Dearness Allowance
01.01.2017	From 132% to 136%


Dearness Allowance will be computed on the basis of Basic Pay i.e. total of pay in running pay band and grade pay. The increased amount of DA installment @ 4% will be paid w.e.f. 01.01.2017.

The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded off to the next higher rupee and the fractions of less than 50 paise may be ignored.

The Dearness Allowance may be drawn on the above rates. **No separate pay slip will be issued.**
