**ORDER**

**Sub. :- Payment of Dearness Allowance to All India Service Officers-revised rates effective from 01.1.2016, 01.7.2016, 01.1.2017 & 01.7.2017 respectively.**

The Government of India, Ministry of Finance, Department of Expenditure vide Office Memorandum F.No.1/2/2016-E.II(B), Dated 4<sup>th</sup> November, 2016, No.1/3/2017-E. II(B), Dated 30<sup>th</sup> March, 2017 and No.1/9/2017-E.II(B), Dated 20<sup>th</sup> September, 2017 modified the Dearness Allowance rates for the employees of the Central Government who draw their pay in revised pay structure as per 7<sup>th</sup> Central Pay Commission as under :-

1.	01.01.2016	0%	0%
2.	01.07.2016	2%	2%
3.	01.01.2017	2%	4%
4.	01.07.2017	1%	5%


The Governor is pleased to decide that the Dearness Allowance payable to All India Service Officers shall stand modified as follows :-

Sr. No.	Date	% of Increase rate	Rate of Dearness Allowance
1.	01.01.2016	0%	0%
2.	01.07.2016	2%	2%
3.	01.01.2017	2%	4%
4.	01.07.2017	1%	5%

The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded off to the next higher rupee and the fractions of less than 50 paise may be ignored.


The Dearness Allowance may be drawn on the above rates. **No separate pay slip will be issued.**
