C I R C U L A R

Sub:- Compulsory retirement under rule 244(2) of the Rajasthan Service Rules.

Vide this Department circular of even number dated the 23rd April, 1990 procedure to be followed for compulsory retirement under rule 244(2) of the Rajasthan Service Rules was outlined in detail. Vide circular dated 25th May, 1990 attention was also invited to this Department various Circulars vide which appellate committees were constituted.

It has now been decided that any person who feels aggrieved of the order under rule 244(2) can make an appeal within a period of 30 days from the date of such an order of retirement to the Appellate Committee and the Appellate Committee will decide the appeal within 90 days from the date of issue of an order retiring an employee under rule 244(2) of the R.S.R.

In order to facilitate expeditious disposal of appeals it has also been decided that as soon as the case of 244(2) of the R.S.R. is decided, all the relevant record on the basis of which a decision has been taken to retire a person compulsorily, should be sent to the Chairman of the Appellate Body immediately. The Chairman of the Appellate Body would
