2. All Heads of Departments (including Divisional Commissioners and District Collectors)

**SUBJECT:** Field postings of government servants facing criminal charges / departmental inquiries – placing the concerned Government servants “Awaiting Posting Orders”.

Dear Madam / Sir,

With reference to the above-mentioned subject your attention is invited to this Department's Circulars of even No. dated July 13, 2001 whereby it had been directed that all those government servants who are facing criminal charges / departmental inquiry under Rule 16 CCA on account of embezzlement of government funds, misappropriation of funds, or serious financial irregularities should not be given field postings or other postings which involve direct contact with the public or handling of cash. Thereafter, vide this Department's Circular dated July 26, 2001 it had been clarified that all those government servants who have already been punished in any criminal proceedings / departmental inquiry under Rule 16 CCA on account of charges of embezzlement of government funds, misappropriation of funds, or serious financial irregularities should also not be given field postings or other postings which involve direct contact with the public or handling of cash.

**Field postings of government servants facing criminal charges / departmental inquiries – placing the concerned Government servants “Awaiting Posting Orders”.**


All Principal Secretaries to Government / Secretaries to Government and Heads of Departments had been requested to immediately prepare a complete list of such government servants and to ensure that if any of such government servants has been given a field posting or a posting which involves direct contact with the public or handling of cash, he / she is immediately shifted from his / her present post to some post other than a field post / post involving direct contact with the people and handling of cash. All Principal Secretaries to Government / Secretaries to Government / Heads of Departments had been further requested to prepare a permanent register for this purpose and to furnish a certificate to this Department certifying that action has been completed in accordance with the directions contained in the above mentioned two Circulars.

A month and a half has already elapsed but we have still not received any response from most of the Departments. The matter has been reviewed by the State Government and it has been decided that all the Government servants who fall under the categories specified in the above mentioned circulars and are still posted against field posts or other posts which involve direct contact with the public or handling of cash **should immediately be placed "Awaiting Posting Orders". This action may be completed within three days from the receipt of this Circular.**

All Principal Secretaries to Government / Secretaries to Government / Heads of Departments are requested to take necessary action immediately and report compliance to this Department. The State Government have also decided that all the Principal Secretaries to Government / Secretaries to Government / Heads of Departments shall be personally responsible for ensuring compliance of these directions.

This matter may be accorded **TOP-MOST PRIORITY.**
