**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Minority Affairs (State and Subordinate) Service Rules, 2017, namely :-

**1. Short title and commencement.-** (1) These rules may be called the Rajasthan Minority Affairs (State and Subordinate) Service (Amendment) Rules, 2020.

(2) They shall come into force from the date of their publication in the Official Gazette.

**2. Amendment of rule 27.-** The existing sub-rule (1) of rule 27 of the Rajasthan Minority Affairs (State and Subordinate) Service Rules, 2017, hereinafter referred to as the said rules, shall be substituted by the following, namely:-

"(1)The Commission shall scrutinize the applications received by them and select the candidates for the post specified at serial number 3 of Schedule-I and serial number 1 of Schedule-II in accordance with the provisions of the Rajasthan State and Subordinate Services (Direct Recruitment by Combined Competitive Examination) Rules, 1999."

**3. Amendment of Schedule-I.-** The existing Schedule-I appended to the said rules shall be substituted by the following, namely:-
