**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Horticulture Subordinate Service Rules, 1965, namely:-

**1. Short title and commencement.-** (1) These rules may be called the Rajasthan Horticulture Subordinate Service (Amendment) Rules, 2021.

(2) They shall come into force from the date of their publication in the Official Gazette.

**2. Amendment of rule 2.-** After the existing clause (a) and before the existing clause (b) of rule 2 of the Rajasthan Horticulture Subordinate Service Rules, 1965, hereinafter referred to as the said rules, the following new clause (aa) shall be inserted, namely-

“(aa) “Board” means the Rajasthan Staff Selection Board;”

**3. Amendment of rule 7.-** In sub-rules (3) of rule 7 of the said rules, for the existing expression “Commission for posts falling in its purview, and by the Appointing Authority in other cases, and the Departmental Promotion Committee of”, the expression “Board or the Appointing Authority, as the case may be, and the Departmental Promotion Committee or ” shall be substituted.

**4. Amendment of rule 10.-** In rule 10 of the said rules,-

(i) in clause (ix), for the existing expression "or in case of posts filled in through the Commission by interview" shall be deleted; and

(ii) in clause (x), for the existing expression "before the Commission", the expression " before the Board" shall be substituted.

**5. Amendment of rule 14.-** In rule 14 of the said rules,-

(i) for the existing expression "Commission", the expression "Board" shall be substituted;

(ii) the existing expression "examination or interview" wherever occurring, the expression “examination” shall be substituted; and

(iii) the existing clause (a) shall be substituted by the following namely:-

“(a) by the Board or by the Appointing Authority, as the case may be, from admission to any examination; and”

**6. Amendment of rule 16.-** In rule 16 of the said rules, for the existing expression "Commission", wherever occurring, the expression "Board" shall be substituted.

**7. Amendment of rule 17.-** In rule 17 of the said rules, for the existing expression "Commission", wherever occurring, the expression "Board" shall be substituted.

**8. Amendment of rule 18.-** In rule 18 of the said rules, for the existing expression "Commission", wherever occurring, the expression "Board" shall be substituted.


**9. Substitution of rule 19.-** The existing rule 19 of the said rules shall be substituted by the following, namely :-

**"19. Scrutiny of Applications.-** The Board or the Appointing Authority, as the case may be, shall scrutinize the applications received by it and require as many candidates qualified for appointment under these rules as seem to it desirable, to appear in written examination conducted by it:

Provided that decision of the Board or the Appointing Authority, as the case may be, regarding the eligibility or otherwise of a candidate shall be final."

**10. Amendment of rule 20.-** In rule 20 of the said rules, for the existing expression "Commission", wherever occurring, the expression "Board" shall be substituted.
