**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Tribal Area Development State and Subordinate Service Rules, 2001, namely:-

**1. Short title and commencement.-** (1) These rules may be called the Rajasthan Tribal Area Development State and Subordinate Service (Amendment) Rules, 2022.

(2) They shall come into force from the date of their publication in the Official Gazette.

**2. Amendment of rule 2.-** In rule 2 of the Rajasthan Tribal Area Development State and Subordinate Service Rules, 2001, hereinafter referred to as the said rules, after the existing clause (a) and before the existing clause (b), the following new clause (aa) shall be inserted, namely:-

“(aa) “Board” means the Rajasthan Staff Selection Board;”

**3. Amendment of rule 7.-** In sub-rule (3) of rule 7 of the said rules, for the existing expression “Commission/Appointing Authority”, the expression “Commission/Board/Appointing Authority” shall be substituted.

**4. Amendment of rule 14.-** In clause (vii) of proviso to rule 14 of the said rules, for the existing expression “Commission/Appointing Authority”, the expression “Commission /Board/Appointing Authority” shall be substituted.

**5. Amendment of rule 18.-** In rule 18 of the said rules, for the existing expression “Commission/Appointing Authority”, wherever occurring, the expression “Commission /Board/Appointing Authority” shall be substituted.

**6. Amendment of rule 20.-** In rule 20 of the said rules, for the existing expression “Commission or the Appointing Authority”, wherever occurring, the expression “Commission, Board or Appointing Authority” shall be substituted.

**7. Insertion of new rule 20-A.-** After the existing rule 20 and before the existing rule 21 of the said rules, the following new rule 20-A shall be inserted, namely:-

**“20-A. Scheme and Syllabus of examination for the post of Hostel Superintendent Grade II.-** (1) The Competitive examination for the recruitment to the post of Hostel Superintendent (Male) Grade-II and Hostel Superintendent (Female) Grade-II shall be conducted by the Board in accordance with the Scheme and Syllabus as specified in Schedule-III.

**8. Amendment of rule 21.-** In rule 21 of the said rules,-

(i) for the existing expression “Commission or by the Appointing Authority”, the expression “Commission, Board or Appointing Authority” shall be substituted; and



- (ii) for the existing expression "Commission/Appointing Authority", wherever occurring, the expression "Commission/Board/ Appointing Authority" shall be substituted.

**9. Amendment of rule 22.-** In rule 22 of the said rules, for the existing expression "Commission/Appointing Authority", the expression "Commission /Board/Appointing Authority" shall be substituted.

**10. Amendment of rule 23.-** In rule 23 of the said rules,-

- (i) for the existing expression "Commission / Appointing Authority", wherever occurring, the expression "Commission /Board/ Appointing Authority/" shall be substituted; and
- (ii) for the existing expression "appear before them/it for interview.", the expression "appear in written examination or interview, as the case may be, conducted by them/it." shall be substituted.

**11. Amendment of rule 24.-** In rule 24 of the said rules,-

- (i) for the existing expression "Commission/ Appointing Authority/ Committee", wherever occurring, the expression "Commission/Board/Appointing Authority/Committee" shall be substituted; and
- (ii) for the existing expression "Commission/Committee", wherever occurring, the expression "Commission/Board/Committee" shall be substituted.

**12. Amendment of rule 26.-** In rule 26 of the said rules, for the existing expression "Commission /Appointing Authority/Committee", the expression "Commission/Board /Appointing Authority/Committee" shall be substituted.

**13. Amendment of Schedule-II.-** In Schedule-II appended to the said rules, under the head Subordinate Service Posts, after the existing serial number 6 and entries thereto and before the existing serial number 7 and entries thereto, the following new serial number. 6A, 6B, 6C and 6D and entries thereto shall be inserted, namely:-

**Scheme and Syllabus of Competitive examination for the post of Hostel Superintendent  
(Male/ Female) Grade-II**

1. The question paper shall be of maximum 100 marks.
2. Duration of the question paper shall be of 2 hours.
3. The question paper shall be of multiple choices.
4. The question paper shall include the following subjects:-
  - (I) **Current Affairs:** Major Current Government issues, happenings and Sports at State, National and International Levels.
  - (II) **Geography and natural resources:**
    - (i) Broad physical features of the world, important places, mountains and oceans.
    - (ii) Ecology and wild-life of India.
    - (iii) Rajasthan physiography: Climate, Vegetation and soil, Regions, Broad physical divisions of Rajasthan. Problems of Population, unemployment, poverty, drought, famines and desertification.
    - (iv) Natural resources of Rajasthan: Mines and Minerals, Forests, Land and Water, Animal resources, Wildlife and Conservation.
  - (III) **Agriculture and Economic Development with special reference to India and Rajasthan:** Food and Commercial Crops of Rajasthan, Agriculture based industries, Major Irrigation and River valley Projects, Projects for the development of the desert and waste-Lands. Major Industries. Tribes and their economy.
  - (IV) **History and Culture:** Major Monuments and literary works. History and Culture of India and Rajasthan with special reference to:-
    - (a) Tribes and their economy.
    - (b) Dialects and Literature.
    - (c) Music, Dance and Theatre.
    - (d) Religious beliefs, cults, saint, poets, Warrior- saints, "Lok Devtas" and "Lok Deviyam".
    - (e) Handicrafts.
    - (f) Fairs and Festivals, Customs, Dresses and Ornaments, with special reference to Folk and Tribal aspects thereof.
  - (V) **General Mental Ability.**
  - (VI) **Logical reasoning and analytical ability.**
  - (VII) **English, Hindi & Mathematics (10<sup>th</sup> class standard).**
  - (VIII) **Administrative setup in Rajasthan at State, District, Tehsil & Panchayat Level.**
  - (IX) **Basic knowledge of Computers.**
