Dear Madam,

Your kind attention is invited to DOPT's OM No. 32/29/2020-EO (MM-II), dated 18/06/2020(Copy enclosed) wherein it has been mentioned that having regard to the need for creating a strong cadre of professionally trained corps of officers, with experience at the Centre and the State, the competent authority has directed that not less than two years' experience at Deputy Secretary/Director level under the Central Staffing Scheme shall be mandatory for empanelment at Joint Secretary level at the Centre in respect of IAS officers from 2007 batch onwards.

2. In this context, it is mentioned that as per extant guidelines, the IAS officers' of 2007 batch would be eligible to be considered for empanelment at Joint Secretary and equivalent level posts at the Centre w.e.f. 01/01/2023. In order to consider their suitability for the above empanelment, not less than two years' experience at DS/Director level under Central Staffing Scheme is mandatory.

3. In order to ensure adequate utilization of Central Deputation Reserve, while applications of all IAS officers who have applied for deputation under Central Staffing Scheme may be forwarded by the State Governments/Cadre Controlling Authorities to this Department, it is



emphasized that in view of the above-mentioned instructions, IAS officers belonging to the 2007-2009 batches may be given requisite priority.

4. A Cadre wise list of IAS officers of 2007-2009 batches who have not yet applied for deputation under Central Staffing Scheme is enclosed at **Annexure-I**.

5. In view of the above, all the State Governments/Cadre Controlling Authorities of IAS officers are requested to again sensitize the IAS officers of the batches of 2007 to 2009 working under their respective Cadres about the contents of DOP&T's OM No. 32/29/2020-EO (MM-II), dated 18/06/2020 and request them to apply on SUPREMO portal for deputation under Central Staffing Scheme. Further, the State Governments/Cadre Controlling Authorities are requested to forward the applications of all such IAS officers (except those who are unwilling) expeditiously to this Department.



Subject: Central Staffing Scheme-Procedure for selection and appointment of officers to Secretariat posts of and above the rank of Under Secretary to the Government of India and to certain non-Secretariat posts- Joint Secretary level empanelment of IAS officers -Reg

OFFICE MEMORANDUM

The undersigned is directed to refer to O.M. No. 38/77/94-EO(SM-I) dated 5/1/1996 detailing the procedure for selection and appointment of officers to Secretariat posts of and above the rank of Under Secretary to the Government of India and to certain non-Secretariat posts and to say that keeping in view the lack of uniformity noted between the IAS(Pay) Rules, 1954 and the Central Staffing Scheme, the Appointments Committee of the Cabinet has directed that the qualifying service for empanelment of IAS officers to Joint Secretary level posts at the Centre would be 16 years aligning it with the period prescribed for grant of Super Time Scale by the Government of India's Decision(DoPT letter No. 20011/4/92-AIS-II dated 28th March 2000) under Rule 3 of the IAS (Pay) Rules, 1954. Having regard to the need for creating a strong cadre of professionally trained corps of officers, with experience at the Centre and the State the Appointments Committee of the Cabinet has further directed that not less than two years' experience at Deputy Secretary/Director level under the Central Staffing Scheme shall be mandatory for empanelment at Joint Secretary level at the Centre in respect of IAS officers from 2007 batch onwards.
