ORDER


The State Higher Education Council (SHEC) was constituted vide even numbered order dated 08.07.2015 and eligibility and service conditions for posting of Vice-Chairman and Member Secretary was prescribed vide order dated 05.10.2016. In continuation of order dated 5.10.2016, certain amendments in eligibility and service conditions of the Member Secretary has been made.

The new eligibility and service conditions for posting of Member Secretary of the State Higher Education Council shall be as prescribed below:-

Minimum Qualification	An eminent academician of the rank of Professor/Principal of Post Graduate College/Associate Professor with five-year experience/Principal of Degree College with five years experience with - a. Ph.D. qualification and published work of high quality. b. Contribution to educational innovation, design of new curricula and courses and technology-mediated teaching-learning process.
Age	Should not be more than 65 years on the date of appointment.
Mode of Selection	Deputation or Tenure posting on contract
Process of Selection	The Government shall appoint Member-Secretary out of the panel of names recommended through proper identification by a selection committee. The selection committee will be as follows- <ul style="list-style-type: none">• Vice-chairman of State Higher Education Council - Chairman• Two Professors/PG College Principals to be nominated by the State Government• Principal Secretary Higher Education• Commissioner College Education The selection committee will invite applications through an open transparent process. Or If the circumstances warrant the State Government may appoint Member Secretary directly on its own.
Pay Scales	The Member Secretary shall be of the rank of Professor and accordingly his/her salary shall be in the RPB Rs. 37400-67000 (PB-4) plus AGP of Rs. 10000. If Member Secretary is a serving person he will be entitled to draw pay of the last post. If he/she is a pensioner his/her pay and HRA will be admissible on net pay if he/she is residing in rented accommodation. DA and HRA shall be admissible on basic pay, if he/she is a retired person. DA will be admissible on net pay and HRA will be admissible on net pay if he/she is residing in rented accommodation.
	If the Member Secretary is appointed on deputation basis, then fixation will be done as per the State Government rules


