NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Forensic Science Service Rules, 1979, namely: -

- 1. Short title and commencement.- (1) These rules may be called the Rajasthan Forensic Science Service (Amendment) Rules, 2023
- (2) They shall come into force from the date of their publication in the Official Gazette.
- 2. **Amendment of Schedule.** In Schedule appended to the Rajasthan Forensic Science Service Rules, 1979.-
