Subject: Extension of timelines for recording of PAR for the year 2022-23 in respect of AIS officers by the reporting / reviewing / accepting authorities – reg.

Sir / Madam,

I am directed to refer to the relevant provisions for recording of PAR under AIS (PAR) Rules, 2007 as amended from time to time. In this regard, reference is invited to the difficulties being faced by AIS officers in submitting self-appraisal / recording of PAR for year 2022-23 due to their engagement in the meetings of G-20 being held under the presidency of India across the country, Karnataka Assembly Elections 2023 and Civic body polls in some States.

2. Accordingly, the matter has duly been considered in this Department and it has been decided with the approval of the Competent Authority to extend the existing timelines for recording PAR for the year 2022-23 by 15 days, in relaxation of Rule 5(1) read with Schedule 2 of AIS (PAR) Rules so as to give sufficient time to each authority, as indicated below:-

- 4. The aforesaid relaxation is accorded as a one-time measure only.
