**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Various Service Rules as mentioned in the Schedule appended hereto, namely:-

**1. Short title and commencement.-** (1) These rules may be called the Rajasthan Various Service (Amendment) Rules, 2024.

(2) They shall come into force with immediate effect.

**2. Amendment.-** After the existing rule as mentioned in column number 3 against each of the Service Rules as mentioned in column number 2 of Schedule appended hereto, the following new rule as mentioned in column number 4 shall be added, namely :-

**"Compassionate appointment to candidates who became orphan due to Corona Virus infectious Disease (Covid-19).-** (1) Notwithstanding anything contained in these rules, the Appointing Authority may fill the vacancies of the post upto level in pay matrix L-9 to be filled in by direct recruitment by appointing a candidate who became orphan due to Covid-19 on compassionate ground, subject to the conditions that,-

- (i) the candidate must be a bonafide resident of the State of Rajasthan; and
- (ii) the candidate fulfills academic and other qualifications and other conditions prescribed under these rules for respective post.

(2) The procedural requirement for selection and appointment such as,-

- (a) computer qualification shall not be insisted upon at the time of appointment. The candidate shall have to possess any of the computer qualification as prescribed in the relevant rules within the period of probation, failing which his/her probation shall be deemed to be extended, unless the appointing authority terminates his/her services finding the performance wholly unsatisfactory;
- (b) training or departmental examination or typing on computer shall not be insisted upon at the time of appointment. The candidate shall however, be required to clear such training or departmental examination or typing test



on computer either in English or in Hindi, within a period of three years, unless the period is relaxed by Department of Personnel, for entitlement for confirmation, failing which his/her appointment shall be liable to be terminated. No annual grade increments shall be allowed until he/she acquires such qualification. On acquiring such qualification, annual grade increments shall be allowed notionally from the date of appointment but no arrears shall be paid:

Provided that the person with benchmark disability appointed under the provisions of this rule shall be exempted from passing the typing test on computer.

(3) Appointment shall not be given to such orphan, if any member of his family is already employed on regular basis under the Central Government or any State Government, Statutory Board, Organisation or Corporation owned or controlled wholly or partially by the Central Government or any State Government at the time of death of his/her parents or at the time of appointment of such orphan.

(4) If the orphan is not in a position to take up employment immediately being a minor, employment may be given to him on attaining the age required for appointment on the post.

(5) Such orphan shall submit an application for appointment to the District Collector concerned. In the event of non-availability of vacancy in the district concerned, the application shall be sent to the Divisional Commissioner who shall arrange appointment in any District under his jurisdiction. If vacant post is not available under the jurisdiction of the Divisional Commissioner, the application shall be referred by the Divisional Commissioner to the Department of Personnel (A-II) for providing appointment.

**Explanation:-** For the purpose of this rule orphan means a person who has not attained the age of eighteen years at the time of death of his biological or adoptive parents who (both) have died due to Corona on or before 31.03.2023 or one of the parents had died in the past and the other died due to Corona on or before 31.03.2023 and who was wholly dependent on the parents at the time of their death."
