I am directed to state that the Ministry of Corporate Affairs (IICA) has established the Indian Institute of Corporate Affairs, as a 'Society' registered under Societies Registration Act, 1860 on 12.09.2008. In order to lead the Institute, the post of DG & CEO in the IICA is urgently required to be filled. The post carries a fixed pay-scale of Rs. 80,000/- p.m. (fixed) (Rs. 2,25,000/- revised as per 7th CPC) with admissible allowances.

The applicant should be aged between 45 years and 65 years as on last date of receipt of application and should be a person of ability, integrity and standing with special knowledge and experience of at least 15 years, in the field relevant to the Institute, who is either, (i) a person of eminence with Master Degree having 15 years of experience in managerial and administrative capacity in Government, Public/Private Sector or reputed Academic institution OR (ii) an officer of organized Group 'A' Service with at least two year service in the HAG of Rs. 67000 79000 or higher grade.
