NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Forest Subordinate Service Rules, 2015, namely:-

- 1. Short title and commencement.- (1) These rules may be called the Rajasthan Forest Subordinate Service (1st Amendment) Rules, 2024.
- (2) They shall be deemed to have come into force from 01.04.2023.
- 2. Amendment of rule 2.- In rule 2 of the Rajasthan Forest Subordinate Service Rules, 2015, hereinafter referred to as the said rules, after the existing clause (l) and before the existing clause (m), the following new clause (la) shall be inserted, namely:-
 - "(la) "Work Charged Employee" means employee working on the posts covered by Schedule- IIA appended to these rules;"
- 3. Amendment of rule 4.- In sub-rule (1) of rule 4 of the said rules, for the existing expression "Schedule-I and Schedule-II", the expression "Schedule-I, Schedule-II and Schedule-IIA" shall be substituted.
 - 4. Amendment of rule 6.- In sub-rule (1) of rule 6 of the said rules,-
 - (i) in clause (a), the existing expression "and", appearing at the end shall be deleted;
 - (ii) in clause (b), for the existing punctuation mark ".", the expression "; and" shall be substituted; and
 - (iii) after the existing clause (b), so amended, the following new clause (c) shall be added, namely:-
 - "(c) the promotion/ upgradation of work charged employees included in Schedule-IIA shall be in accordance with the procedure laid down in Part-VA of these rules."
- 5. Insertion of Part -VA.- After the existing Part-V and before the existing Part -VI of the said rules, the following new Part- VA shall be inserted, namely:-

"Part -VA

Procedure for promotion/upgradation of Work Charged Employees

- 38A. Criteria, eligibility and procedure for promotion/ upgradation.- (1) Only those Work Charged Employees who are serving on and after 1st April 2023 shall be considered for promotion/upgradation as provided under these rules.
- (2) The Work Charged Employees working as on 01.04.2023 shall be considered for promotion/upgradation on completion of regular and satisfactory service of 9 years, 18

years and 27 years from the date of their being declared as semi-permanent as per the regulations and directions issued by the Government, from time to time.

- (3) The persons enumerated in column 3 of Schedule-IIA appended to these rules shall be eligible for promotion/ upgradation to the posts specified in column 4, column 5 and column 6 thereof, subject to completion of their regular and satisfactory service of 9, 18 and 27 years from the date of their being declared semi-permanent respectively.
- (4) With the promotion/upgradation of a work charged employee from a lower post mentioned in column 3 of Schedule-IIA to the post mentioned in column 4, column 5, column 6 of Schedule-IIA, the post previously occupied by the Work Charged Employee before the promotion/upgradation i.e. the post mentioned in column 3, column 4 and column 5 of Schedule IIA shall stand abolished with immediate effect and no direct recruitment to these posts shall be made in future.
- (5) The authority competent to grant 9 years, 18 years and 27 years selection scale (A.C.P.) to the Work Charged employees shall be competent to grant the promotion/upgradation of Work Charged employees as per these rules.
- (6) The Government may issue instructions for provisionally dealing with the promotions, appointments or other ancillary matters in an equitable and fair manner of persons who may be under suspension, or against whom departmental proceeding is under progress, at the time promotion / upgradation is considered to a post to which they are eligible or would have been eligible but for such suspension or pendency of such enquiry or proceedings.
- (7) The above provisions shall be applicable only for the purpose of pay and pension fixation and shall not apply for any other purposes.
- (8) The provisions of Part-VA shall have effect notwithstanding anything to the contrary contained in any other provisions of these rules.
- (9) The Standing Orders of 1973 and all orders issued in respect of the Work Charged Employees of the Forest Department and in force immediately before commencement of the Rajasthan Forest Subordinate Service (Amendment) Rules, 2023, are hereby repealed:

Provided that any action taken under the rules and orders superseded shall be deemed to have been taken under the provision of these rules."

6. Insertion of new Schedule-IIA.- After the existing Schedule-II and before the existing Schedule-III appended to the said rules, the following new Schedule-IIA shall be inserted, namely:-
