NOTIFICATION

In exercise of the powers conferred by Article 233 and 234 read with proviso to Article 309 of the Constitution of India and all other powers enabling him in this behalf, the Governor of Rajasthan in consultation with the Rajasthan Public Service Commission and High Court of Judicature for Rajasthan, hereby makes the following rules further to amend the Rajasthan Judicial Service Rules, 2010, namely:-

- 1. Short title and commencement.- (1) These rules may be called the Rajasthan Judicial Service (Amendment) Rules, 2024.
- (2) They shall come into force from the date of their publication in the Official Gazette.
- 2. Amendment in rule 10.- In rule 10 of Rajasthan Judicial Service Rules, 2010, hereinafter referred to as the said rules,-
- (i) in the existing title, between the expressions "Persons with Disabilities" and "and Women candidates" the expression ", Ex-Servicemen" shall be inserted.
- (ii) after the existing sub rule (6), a new sub rule (7) shall be added by the following, namely:-
- for Ex-Servicemen in the recruitment to the service shall be in accordance with the rules of the State issued from time to time."
 - 3. Amendment in rule 17.- In rule 17 of the said rules,-
- (i) the existing proviso(vi) including Explanation to rule 17 shall be substituted by the following, namely:-
- "(vi) the age relaxation for Ex-Servicemen will be admissible as applicable in the State from time to time,-

Explanation: The relaxation in age will be admissible only in one category, mentioned in the proviso above."

(ii) after the existing Explanation, a new proviso (vii) shall be added by the following, namely:-

"(vii) the age relaxation for persons with benchmark disabilities will be admissible as applicable in the State from time to time."

4. Amendment in Rule 24.- The existing proviso to rule 24 of the said rules shall be substituted by the following, namely:-

"Provided that the Recruiting Authority shall not recommend a candidate of Scheduled Castes or Scheduled Tribes or Persons with benchmark disabilities or Ex-Servicemen categories unless he obtains minimum 35% marks in the aggregate of written examination and interview, in case of other candidates unless he obtains minimum 40% marks in the aggregate of written examination and interview and in case of non-availability of Ex-Servicemen, further more five percent relaxation shall be given."

- 5. Amendment in rule 33.- After the existing proviso (c) to sub rule (i) of rule 33 of the said rules, a new proviso(d) with explanation and new proviso (e) shall be added by the following, namely:-
- "(d) the age relaxation for Ex-Servicemen will be admissible as applicable in the State from time to time.

Explanation: The relaxation in age will be admissible only in one category, mentioned in the proviso above.

- (e) the age relaxation for persons with benchmark disabilities will be admissible as applicable in the State from time to time."
- 6. Amendment in rule 48.- After sub rule (4) of rule 48 of the said rules, the following new sub rule (5) shall be added, namely:-
 - "(5) If for any reason, delay in grant of ACP goes beyond one year, one additional increment for every year delay shall be granted subject to adjustment while drawing the arrears on grant of ACP."
- 7. Amendment in rule 49.- In rule 49 of the said rules, for the existing expression "25 percent", the expression "35 percent" shall be substituted.
- 8. Amendment in rule 50.-In rule 50 of the said rules, for the existing expression "10 percent", the expression "15 percent" shall be substituted.

9. Substitution of Schedule-I.- The existing Schedule I appended to the said rules shall be substituted by the following, namely:-

10. Amendment in Schedule IV.- In the existing first proviso of Schedule IV, between the expressions "Scheduled Tribe category" and "shall be deemed" the expression "or Persons with benchmark disabilities or Ex-Servicemen" shall be inserted

11. Amendment of Schedule VII.- In Schedule VII appended to the said rules,-(i) in the existing table of item (b), under the heading "Minimum marks", for the existing sub heading "For SC/ST Candidates" the expression "For SC/ST/PwBD/ Ex-Servicemen Candidates" shall be substituted.

(ii) after the existing table of item (b) and before item(c), the following new proviso shall be added as under:-

"Provided that in case of non-availability of Ex-Servicemen, further more five percent relaxation shall be given."
