I am directed to say that one post of Joint Commissioner (Fisheries) in Level 13 (Rs. 123,100-2,159,500) in the Pay Matrix in the Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying, Krishi Bhawan, New Delhi is proposed to be filled up on Deputation basis (including Short Term Contract) from amongst the Officers under the Central Government or State Governments or Union territory Administration or Statutory organisations or autonomous organisations or public sector undertakings or recognized universities or recognised research institutes:

- (a) (i) holding analogous posts on regular basis in the parent cadre or Department;
OR
(ii) with five years of service in the grade rendered after appointment there to on a regular basis in Level 12 (Rs.78800-209200/-) in the pay matrix or equivalent in the parent cadre or Department; and
- (b) Possessing the following educational qualifications and experience:

Essential:-

- (i) Masters Degree in Zoology with specialisation in Fisheries or M. F. Sc. Or M. Sc. in Marine Biology or M. Sc. in Industrial Fisheries or M. Sc. In Aquaculture or M.Sc. in Fisheries Science from a recognised University or Institute;
- (ii) ten years of experience of research or development in the field of Fisheries (Inland or Marine or Aquaculture) including management, policy and planning, formulation and monitoring of development Schemes for fisheries and trade or fishery health related matter from a Central Government or State Government Department or Union territory Administration or Statutory or Autonomous Organisation or Public Sector Undertaking or recognised University or Recognised Research Institute.

Desirable Qualification: Doctorate degree in Zoology from a recognised University or Institute.

2. The Period of deputation (including short term contract) including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation/department of the Central Government shall ordinarily not exceed five years.

3. The maximum age limit for appointment on deputation shall be not exceed fifty-six years as on the last date of receipt of applications. The pay of the officer selected will be governed by the provisions laid down in the Department of Personnel and Training OM No.6/8/2009-Estt.(Pay-II) dated 17th June, 2010 as amended from time to time.

4. Applications from eligible officers in the enclosed proforma (in duplicate) may be forwarded through proper channel to the **Under Secretary(Admn), Ministry of Fisheries, Animal Husbandry, and Dairying, Department of Fisheries, 1st Floor, Chander Lok Building, 36 Janpath, New Delhi-110001** within 60 days from the date of publication of this advertisement in the Employment News along with up to date APARs for the last 5 years, in original or photocopies duly attested by an officer of the level of Under Secretary or above, Vigilance Clearance Certificate, Integrity Certificate and the Certificate of major/minor penalty imposed on the officer during the last 10 years of his service. The Cadre Controlling Authority may also certify to the effect that the particulars furnished by the officer have been verified and found correct.
