Guidelines

Application to ADRC Visiting Researcher Program FY2024

1. Objectives

Toward the promotion of multilateral cooperation for disaster risk reduction in Asia, Asian Disaster Reduction Center (hereinafter "ADRC") continues to implement the Visiting Researcher Program in FY2024 by inviting disaster risk reduction (DRR) professionals from ADRC member countries who wish to further expand their knowledge and skills on disaster risk management by participating in various types of activities to be facilitated by ADRC.

2. Qualifications

- (1) Applicants must be a DRR professional* who have engaged in activities related to disaster risk reduction and will continue to do so after the program; and
- (2) Applicants must possess a sufficient command of English to undertake their assignments during the program.

* Members of National Platform and relevant DRR organizations in ADRC member countries other than officials who work for ADRC counterpart organizations may apply for the Program with the official recommendation by the head of the ADRC counterpart organizations.

3. Period of Research

ADRC Visiting Researcher Program will be conducted for a period of 0.5 months from November to December as an online program and for a period of 2.5 months from January to March 2025 as an in-person program.

4. Duties and Responsibilities

- (1) Visiting researchers shall:
 - a. conduct research activities based on their own research plan;
 - b. join online and onsite meetings and seminars organized for the VR program;
 - c. visit specialized organizations and facilities, and attend lectures and events in relation to DRR topics; and
 - d. participate in appropriate ADRC activities such as compiling information on natural disasters and government activities of their own countries, and supporting meetings and events organized by the ADRC.
- (2) Visiting researchers are not allowed to be engaged in activities other than ADRC's activities during their terms of assignment of the in-person program without prior agreement between the counterpart organization of the participant's country and ADRC. Also, they are not allowed to leave their duty station (ADRC in Kobe, Japan) during their terms of assignment without prior agreement between the counterpart organization of the participant's country and ADRC.

5. Stipend and Expenses

- (1) ADRC will provide each visiting researcher with a single guest room and a daily allowance (JPY3,500 per day) during the term of assignment of the in-person program. The cost of heating, lighting, water and communication at the guest room will be borne by visiting researchers and deducted from the above-said allowance;
- (2) ADRC will cover <u>the most economical</u> round-trip air ticket from the home country to Kobe, Japan;
- (3) ADRC will not cover visa application fees or the costs related to the visa application; and
- (4) ADRC will cover half of the traveler's insurance during the stay in Japan (this insurance does not cover for the round-trip between the home country and Japan). The remaining half will be deducted from the daily allowance.



(Concerning the Overseas Travel Insurance) This insurance covers the fee for treatments of injuries and illness that occurred during the stay in Japan. However, for illness or injury that was under treatment from before arrival to Japan, or untreated injuries and illness occurring before the travel, any treatment becoming necessary during your stay in Japan may not be covered by the insurance. In this case, the applicant may be asked to cover the medical treatment fee by themselves. In case you have any illness or injury prior to your travel, consider having on your own insurance with enough coverage.

6. Application Procedures

Applicants must submit the following documents <u>through a recommending organization</u>. <u>Applicants</u> <u>from outside the ADRC counterpart organization must submit recommendation letters from both</u> <u>their own organization and the ADRC counterpart organization (4 & 5)</u>. A complete set of documents must be submitted via email (<u>adrcvrp@adrc.asia</u>) by the due date. Application with incomplete documents cannot be accepted.

- (1) Application form (with a photo): Form (A)
- (2) Medical certificate: Form (B)
- (3) Academic certificate of the highest degree (photocopy or original)
- (4) Recommendation letter: Form (C)
 (to be signed by the head of the ADRC counterpart organization in each member country on its letterhead)
- (5) Recommendation letter: Form (C)
 *Only for applicants from outside the ADRC counterpart organizations
 (to be signed and sealed by the head of the applicant's own organization on its letterhead)
- (6) Employment certificate: Form (D)
 (to be signed and sealed by the head of the applicant's own organization on its letterhead)

7. Selection and Notification

- (1) Selection will be made by screening application documents, particularly considering the level of contribution and the relevance of the proposed research activities to the ADRC activities;
- (2) Priority may be given to those countries which have paid the annual membership fee and which have not sent visiting researchers in recent years;
- (3) In case a selected visiting researcher becomes unable to participate in the program due to an inevitable reason, the counterpart organization of the participant's country should notify ADRC without delay. In this case, ADRC may select a substitute from the list of candidates.
- (4) Selection results will be notified by 31 August 2024.


