Subject: Appointment to the Post of Chairperson of the Land Ports Authority of India (LPAI) on deputation Basis – inviting applications-reg.

Sir/Madam,

Government of India, Ministry of Home Affairs (Department of Border Management) has established Land Ports Authority of India (LPAI) under the Land Ports Authority of India Act, 2010 (31 of 2010) to put in place systems which address security imperatives and for the development and management of facilities for cross border movement of passengers and goods at designated points along the international land borders of India and for matters connected therewith or incidental thereto.

2. The post of Chairperson, Land Ports Authority of India (LPAI), (Additional Secretary level) will fall vacant on **02.12.2024**.

3. In pursuance of the above, applications are invited for preparing a panel of names to be considered by a Search-cum-Selection Committee for appointment to the post of Chairperson of the Land Ports Authority of India (LPAI). Applications are invited from amongst the persons who have special knowledge and experience in the field of security, transport, industry, commerce, law, finance or public administration.

4. The terms and conditions of service as well as terms for selection of the Chairperson of the Authority shall be as under: -

(i) The Chairperson of the Authority shall be of the rank of Additional Secretary to the Government of India and shall be chosen from amongst person who have special knowledge and experience in the field of security, transport, industry, commerce, law, finance or public administration.

(ii) The Chairperson shall be selected on deputation or contract basis.

(iii) Eligibility for appointment on deputation basis: -

In case of appointment on deputation basis, the Chairperson would be selected from amongst the persons, who is in the service of Government of India or State Government, and

(a) Holding the post of Additional Secretary equivalent to the Government of India in level 15 of the pay matrix of CCS (Revised Pay) Rules, 2016 OR equivalent post in Government of India or State Government;

OR

(b) holding the post of Joint Secretary to the Government of India (in level 14 of the pay matrix of CCS (Revised Pay) Rules, 2016 OR equivalent post for a period of not less than five years in Government of India or State Government.

(iv) In Case the appointment is on contract basis, the eligibility shall be determined by the Search-cum-Selection Committee.

5. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of applications.


6. As per the procedure laid down in DoPT O.M No. 27/2/2009-EO (SM. II) dated 16th July, 2009, appointment to the post of Chairperson will be made after the approval of ACC. The selected candidate will give his/her consent to join within the stipulated period. If the candidate does not join within 30 days, a 15 days' notice would be issued to him/her to either join or to face debarment as per laid down procedure.

7. For qualifications, terms of office, conditions of service etc., the Land Ports Authority of India Act, 2010 and the Land Ports Authority of India Rules, 2011 notified there under may be referred to in the website at <http://mha.gov.in> and <http://lpai.gov.in>

8. Names of willing and eligible officers may be recommended to this Department along with cadre clearance, vigilance clearance, APAR dossiers/certified APARs for the last five years, details of debarment & cooling off in respect of past Central deputation. In case the officers are currently on central deputation, their nomination may be forwarded with the approval of the Minister-in-Charge concerned.

9. **Last Date of receiving applications is 27th August, 2024. Application received after this date will not be considered. The persons already in service should send their application through their Cadre Controlling Authority. An advance copy of the application can be sent directly. However, in absence of official recommendation along with cadre clearance, vigilance clearance, APAR dossiers/certified APARs for the last five years, details of debarment & cooling off in respect of past Central deputation the application will not be considered.**

10. Application Procedure: Interested and eligible person are requested to send their application in the prescribed format (**Annexure-A**), along with relevant certified copies of required documents through proper channel on or before last day of receiving applications, i.e. 27th August, 2024. Incomplete applications received after the last date shall not be considered.

Search-cum-Selection Committee also reserves the right to reject any/or all applications received for the office of Chairperson of Land Port Authority of India without assigning any reason.
