NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Language and Library (State and Subordinate) Service Rules, 2013, namely:-

1. Short title and commencement.— (1) These rules may be called the Rajasthan Language and Library (State and Subordinate) Service (Amendment) Rules, 2024.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. Amendment of rule 2.— After the existing clause (a) and before the existing clause (b) of the Rajasthan Language and Library (State and Subordinate) Service Rules, 2013, hereinafter referred to as the said rules, the following new clause (aa) shall be inserted, namely:-

“(aa) “Board “means the Rajasthan Staff Selection Board;”


3. Amendment of rule 19.— In rule 19 of the said rules,-

- (i) for the existing expression “Commission/Appointing Authority”, wherever occurring, the expression “Commission, Board or Appointing Authority” shall be substituted; and
- (ii) in clause (a), for the existing expression “Commission or by the Appointing Authority”, the expression “Commission, Board or Appointing Authority” shall be substituted.

4. Amendment of rule 21.— In rule 21 of the said rules, for the existing expression “Commission or the Appointing Authority”, wherever occurring, the expression “Commission/Board or Appointing Authority” shall be substituted.

5. Amendment of rule 23.— In rule 23 of the said rules, for the existing expression “Commission or the appointing authority”, wherever occurring, the expression “Commission, Board or Appointing Authority” shall be substituted.

6. Amendment of rule 24.— In rule 24 of the said rules, for the existing expression “Commission or the Appointing Authority”, the expression



“Commission, Board or Appointing Authority” shall be substituted.

7. Amendment of rule 26 - In rule 26 of the said rules,-

(i) in heading, for the existing expression " the Commission or the Committee", the expression "the Commission or the Board" shall be substituted;

(ii) for the existing expression "Commission or the Committee referred to in column 7 of the Schedule-II", the expression "the Commission or Board " shall be substituted; and

(iii) in proviso,-

(a) for the existing expression "Commission or the Committee", wherever occurring, the expression "Commission or Board" shall be substituted; and

(b) for the existing expression "forwarded by the Commission", the expression "forwarded by the Commission or Board, as the case may be," shall be substituted.

8. Amendment of rule 28.- In rule 28 of the said rules, for the existing expression "Commission or the committee referred to in column 7 of Schedule-II", the expression "Commission or Board, as the case may be," shall be substituted.

9. Amendment of Schedule-I.- The existing Schedule-I, appended to the said rules shall be substituted by following, namely:-




