## **1. ABOUT NPC**

Governance mechanisms, policy-making, program design, project implementation, and evaluation across various agencies are vital for socio-economic development and growth. This residential training program revisits key aspects of institutions, policy making, governance, and project implementation in national and regional development contexts. It aims to enhance the skills of policymakers, program designers, and implementers through shared experiences, case studies, and hands-on exercises in thematic areas detailed in the brochure.

## **3. LEARNING OBJECTIVES**

- The training programme highlights institutional framework and dynamics, governance system and strategies, policy making and scheme design and implementation and evaluations and related features. It opens a wider canvas for learning and deliberations on a spectrum of thematic areas / sectors and sub-sectors and brings together specialists and practitioners from various cadres / institutions among faculty and participants as well as from public and private enterprises
- In this programme we will visit the institutional features, governance aspects and strategies, project conceptualisation, sectoral policy evolution and programme development and Monitoring & Evaluation in a collective and deliberative process. It brings experiences, case examples and insights with undertaking case exercises reflecting of policy making, guidelines development etc and M&E activities and project implementation experiences. The coverage is sought to span a broad context across industry/manufacturing, health, transport, energy, environment, science and technology and a few domains of infrastructure development etc
- Further delving into the public goods provisioning landscape and reflecting on the urban and rural development aspects, as well as address some of the notified rules/ acts and



provisions and reflect on achievements and a way forward oriented policy evolution roadmaps.

#### **4. BROAD PROGRAMME COVERAGE**

The following key topics are sought to be covered during the training programme along with indicated sub components (Please note : The themes/sub-themes may evolve/change etc to strengthen the programme coverage and to meet learning objectives).

1. Review of the policies and policy making features/processes and the history and evolution of regimes, democratic principles, and nation-states. Further, exploration of civilization contexts, democratic paradigms, and institutional frameworks, along with organizational behavior and the prospects for future developments.
2. Examination of the nature of institutions, their roles, rules, and networks, and principles of administration. Coverage of service provisions, rights, and duties, and highlights regarding federal framework and local governance, while addressing challenges in coordination and revitalizing systems for public interest.
3. Exploration of the policy making and political psychology aspects, and focusing on political and institutional will. Revisiting development needs, multi-level governance, policy gaps, stakeholder consultations, and include field insights, data reviews, case sharing, and discussions on policy design and implementation. Exploration of mental/mind frameworks and cognitive strategies to contribute to and strengthen policy making and choice making processes, focusing on strengthening sustainable cognitive structures and informing policy design and interventions.
4. Addressing Indian industrial development features covering industrial clusters, and Micro/Small/Medium and Large Enterprises in both formal and informal sectors. Further, examination of the cluster approach, competitive and comparative advantages, industrial cluster experiences, incentive schemes, industrial park ratings, cluster rating methodologies, and prospects for product and technology mapping.
5. A focus on infrastructure development by examining case study(ies) on infrastructure needs, gap identification, and solutions. We will explore key infrastructure areas that drive economic growth to address and enhance infrastructure strengthening aspects.
6. A revisit to the Health Sector scenario and policy framework and related evolution in recent years and addressing of challenges and dynamics for the sector. Reflecting on case study(ies) or new range of initiatives and related evolving efforts to contribute to strengthen health sector
7. Exploring of the energy scenario and emerging roadmap(s) for energy provisioning and services including centralised and decentralised approaches and related developments within renewable and non-renewable energy sub-sectors and experiences in the pathway of energy security
8. Addressing environmental protection, management, and sustainability aspects and focusing on Circular Economy principles.
9. The context of Impact Evaluation and M&E features and evolving aspects on monitoring and evaluation of programmes / schemes and projects and the approaches including concurrent M&E strengthening and utilising / integrating additional productivity indicators.



10. Addressing social issues within policy making and program design such as in sectors like Human Resources and Skill Development, human rights and various other dimensions.

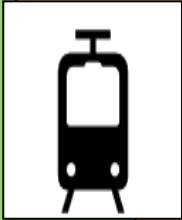

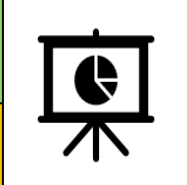
