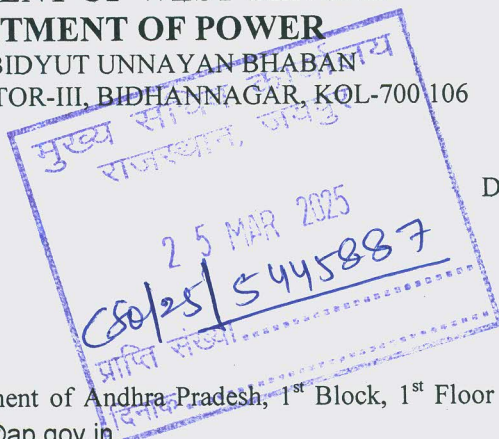

A vacancy exists in the post of Member(Law), West Bengal Electricity Regulatory Commission.


2. The Selection committee constituted under Section 85 of the Electricity Act, 2003 for the purpose of selection of Member of the Commission, has decided to seek nominations of suitable persons for this position, from all State Government, Ministry of Power, Department of Personnel and Training, Government of India.
3. Under the provisions of the Electricity Act, 2003, a Member of the Commission shall be a person of ability, integrity and standing who has adequate knowledge of the Act and has shown

capacity in dealing with problems relating to engineering, finance, commerce, economics, law or management.

4. In compliance with the judgement of the Hon'ble Supreme Court, dt. 12.04.2018 in Civil Appeal No. 14697 of 2015, the instant vacancy requires a person, who is , or has been holding a Judicial Office or is a person possessing professional qualification with substantial experience in the practice of Law, who has the requisite qualifications to have been appointed as a Judge of the High Court or a District Judge.
5. The member shall hold the post for a term of 5(five) years from the date he/she joins the office or till he/she attains the age of 65 years, whichever is earlier, Further, the member shall not hold any other office during this period.
6. The salary, allowances and other terms and conditions of service of the Member shall be governed by the West Bengal Electricity Regulatory Commission (Salary, Allowances and Conditions of service of the Chairperson & other Member etc) Rules, 2004 as amended vide memo no. 28-PO/O/III/3R-07/2003(Pt), dated 14.02.2007. Details of application format is available in www.wbpower.gov.in .
7. I would request you to kindly forward nomination of suitable persons possessing requisite qualification and experience as prescribed in the Act, so as to reach us during working hours by 28th April, 2025 along with two copies of CVs in prescribed format of the persons nominated (Format enclosed). Further, in respect of nominated persons in service, copier of this ACR Dossiers covering a period of the last 5(five) years may kindly be enclosed.
8. While sending such nominations, it may kindly be ensured that the person nominated does not have any financial or other interest which is likely to affect prejudicially his/her functions as member of the West Bengal Electricity Regulatory Commission.
