

The ICTSR a government-mandated institution dedicated to imparting training to officers of the Central Secretariat Service (CSS) and other organized or subsidiary services. These officers play a critical role in the formulation, execution, monitoring, and review of policies in Central Government Ministries and Departments, forming the backbone of governance.

Basis for GST Exemption

Notification Dated 28.06.2017 (Heading 9964 Onwards):
 The Ministry of Finance, Department of Revenue, in its notification dated 28.06.2017 (enclosed for reference), stipulates GST

exemptions for various services provided to the Government. This principle enables the Government to exempt specific services provided by agencies from the liability of GST payment.

Relevance to ICTSR's Functions:

While the specific stipulation under SI. No. 72 of the notification (Heading 9992) may not explicitly name ICTSR, the institute's role in imparting training to government officers aligns with the spirit and principle of the notification. ICTSR functions as a nonprofit organization, delivering training exclusively for government personnel, and its services merit consideration for exemption from GST liability.

GENERAL INSTRUCTIONS.

- Please ensure that candidate names and passport photocopies are submitted at least 60 days in advance. This allows the (ICTSR) to make necessary arrangements for travel, accommodations, faculty booking, visa processing, and program planning.
- For accompanying spouse and/or children (aged 5 to 12 and above), the estimated charges for the entire duration will be INR 4,69,000 plus 18% GST. Payment should be made in advance to ICTSR.
- Nominations will be accepted based on seat availability and receipt of the participation fee by the specified deadline.
